



## Grand View Hotel Member's Draw Terms & Conditions

1. The Member's Draw commences 21 May 2026.
2. Draws are held every Thursday with the following schedule: \$50 Cash Draws at 5:00pm, 5:30pm, 6:30pm and 7:00pm; Major Cash Draw at 6:00pm.
3. The promoter is the Grand View Hotel.
4. Persons under 18 years of age, employees of the Grand View Hotel, Kickon Group, or any associated agencies or parties are not eligible to enter.
5. Immediate family members of any employee associated with the draw are not eligible to enter.
6. Employees who have ceased employment within the previous 6 months are not eligible to win.
7. Entry requirements:
  - a. Entrants must be a current member of the Grand View Hotel.
  - b. All current active members are automatically entered into the Major Cash Draw.
  - c. Members and guests receive one (1) entry into the \$50 Cash Draws via a kiosk swipe on the day of the draw.
8. Members are randomly selected via the venue's membership database.
9. Prizes are drawn in the following order and structure:
  - a. **\$50 Cash Draws** (4 draws per night — drawn at 5:00pm, 5:30pm, 6:30pm & 7:00pm). Each draw is redrawn until a winner is present and claims their prize.
  - b. **Major Cash Draw** (drawn once only at 6:00pm).
10. The Major Cash Draw jackpot starts at \$500.
11. If the Major Cash Draw prize is not claimed at the time of the draw, the jackpot will increase by \$100 for the following week's draw. This will continue to jackpot until the selected member is present and claims their prize.
12. Members must be present at the Grand View Hotel and have their membership card at the time of the draw. The Major Cash Draw is drawn once only — there are no redraws on the night.
13. Staff will announce the name drawn in each area of the venue and will endeavour to ensure all patrons are informed.
14. Each \$50 Cash Draw will be redrawn until a present member claims their prize within the 2-minute timeframe.
15. Management and staff reserve the right to withdraw or amend any prize or promotion without notice.
16. The venue, management and staff accept no responsibility for system errors or omissions.
17. The conductor's decision is final and no correspondence will be entered into.
18. Patrons may be required to produce suitable ID to verify their identity before any prize is awarded or redeemed.
19. Prior notice may be provided in the event of any delay, change or cancellation of a draw.
20. A copy of these T&Cs will be posted and made available in the immediate area where the draw is conducted.
21. Should the jackpot amount reach \$5,000, a forced Barrel Draw will be implemented, with entries weighted according to card usage including kiosk swipes, POS transactions and EGM play.
